- Over 150 Ukrainian evacuees have been homed in North Lincolnshire, with two families settled in Brigg. Checks are made that none have committed crimes of violence against women and children and no links to terrorism. Help is given with education, medicine and employment.
- Cemetery Path works will be started soon. Delays with engaging a contractor.
- Two grants given in Brigg to help with Jubilee celebrations.
