Cllr Waltham/Cllr C Sherwood

- Continue to urge caution re covid cases, before some level of normality is resumed. Ancholme Leisure Centre is being used as an outreach vaccination centre, but the Baths Hall continues to be the main one. Major employers across North Lincolnshire being urged to encourage their employees to take up the vaccine.
- Requested that the bollards in the town centre that have been damaged in vehicular bumps are fixed.
- New PSPO consultation underway. Enforcement penalties of cycling in pedestrian areas are being considered. Town and Parish Councils will be consulted.
- Requested a pedestrian crossing on Bridge Street. Working with Andrew Percy MP, sourced Govt. Dept. of Transport money for this.
- Shop-a-dropper scheme launched, where residents can upload dashcam or video footage of littering from vehicles can be uploaded to Council Website for enforcement.

Cllr questions to NLC Ward Councillors

- **Cllr Eardley** – reported state of footpath and overgrown hedge around the empty property on Glebe Road. Garden used as a dumping ground. Cllr Waltham thinks it may be ONGO responsibility and will report to Environmental Health.

Doctors Surgery footpath has sunk where telecom company has dug footpath.
